

- Per Webster's
 - Rules of behavior based on ideas about what is morally good and bad
 - ethics: an area of study that deals with ideas about what is good and bad behavior: a branch of philosophy dealing with what is morally right or wrong
 - : a belief that something is very important

Unethical behavior:

- Not morally correct;
- Not conforming to a high moral standard: morally wrong: not ethical;
- Not conforming to approved standards of social or professional behavior;
- Taking advantage of one or more third parties for personal or institutional gain, that is often in the short term.







Strategies to address institutional unconscious bias

- Develop concrete, objective indicators & outcomes for hiring, evaluation, and promotion to reduce standard stereotypes.
- Develop standardized criteria to assess the impact of individual contributions in performance evaluations.
- Develop and utilize structured interviews and develop objective evaluation criteria for hiring.
- Provide unconscious bias training workshops for all constituents.





Declaration of Geneva

- I solemnly pledge to consecrate my life to the service of humanity;
- I will give to my teachers the respect and gratitude that is their due;
- I will practice my profession with conscience and dignity;
- The health of my patient will be my first consideration;

Declaration of Geneva

- I will respect the secrets that are confided in me, even after the patient has died;
- I will maintain by all the means in my power, the honour and the noble traditions of the medical profession;
- My colleagues will be my sisters and brothers;
- I will not permit considerations of age, disease or disability, creed, ethnic origin, gender, nationality, political affiliation, race, sexual orientation, social standing or any other factor to intervene between my duty and my patient;

Declaration of Geneva

- I will maintain the utmost respect for human life;
- I will not use my medical knowledge to violate human rights and civil liberties, even under threat;
- I make these promises solemnly, freely and upon my honour

American Medical Association Principals of Ethics

- A physician shall be dedicated to providing competent medical care, with compassion and respect for human dignity and rights.
- A physician shall uphold the standards of professionalism, be honest in all professional interactions, and strive to report physicians deficient in character or competence, or engaging in fraud or deception, to appropriate entities.

American Medical Association Principles of Ethics

- A physician shall respect the law and also recognize a responsibility to seek changes in those requirements which are contrary to the best interests of the patient.
- A physician shall respect the rights of patients, colleagues, and other health professionals, and shall safeguard patient confidences and privacy within the constraints of the law.

American Medical Association Principles of Ethics

- A physician shall continue to study, apply, and advance scientific knowledge, maintain a commitment to medical education, make relevant information available to patients, colleagues, and the public, obtain consultation, and use the talents of other health professionals when indicated.
- A physician shall, in the provision of appropriate patient care, except in emergencies, be free to choose whom to serve, with whom to associate, and the environment in which to provide medical care.

American Medical Association Principles of Ethics

- A physician shall recognize a responsibility to participate in activities contributing to the improvement of the community and the betterment of public health.
- A physician shall, while caring for a patient, regard responsibility to the patient as paramount.
- A physician shall support access to medical care for all people.

American Medical Association

- "Healthcare is a fundamental human good..."
- "Society has an obligation to make access to an adequate level of care available to all its members, regardless of ability to pay."

NAHU Code of Ethics

- To hold the selling, service and administration of health insurance and related products and services as a professional and public trust and do all in my power to maintain its prestige.
- To keep paramount the needs of those whom I serve.

 To respect my clients' trust in me, and to never do anything which would betray their trust or confidence.

NAHU Code of Ethics (continued)

- To give all service possible when service is needed.
- To present policies factually and accurately, providing all information necessary for the issuance of sound insurance coverage to the public I serve.
- To use no advertising which I know may be false or misleading.
- To consider the sale, service and administration of health insurance and related products and services as a career, to know and abide by the laws of any jurisdiction Federal and State in which I practice and seek constantly to increase my knowledge and improve my ability to meet the needs of my clients.

NAHU Code of Ethics Continued

- To be fair and just to my competitors, and to engage in no practices which may reflect unfavorably on myself or my industry.
- To treat prospects, clients and companies fairly by submitting applications which reveal all available information pertinent to underwriting a policy.
- To extend honest and professional conduct to my clients, associates, fellow agents and brokers, and the company or companies whose products I represent

Case Study: Moda Code of Conduct

- Standards of conduct
 - Observe the highest standards of professionalism at all times.
 - Exhibit a high degree of personal integrity at all times.
 - Refuse to engage in or tolerate any fraud, misuse, abuse or waste of resources.
 - Honor the privacy of employees, members, and providers.
 - Show respect for others we encounter in our business activities and treat them fairly.

Case Study: Moda Code of Conduct


- Standards of conduct (continued)
 - Solicit the options of others as appropriate and encourage different viewpoints when warranted.
 - Seek to resolve dissent and discord, and, if it cannot be resolved, keep it in perspective and respect and support the decision and the decision-maker(s).
 - Encourage others to report violations of this Code of Conduct and protect those who do report.

Case Study: NFL

- Conduct by anyone in the league that is illegal, violent, dangerous, or irresponsible puts innocent victims at risk, damages the reputation of others in the game, and undercuts public respect and support for the NFL
- It is not enough simply to avoid being found guilty of a crime. We are all held to a higher standard and must conduct ourselves in a way that is responsible, promotes the values of the NFL, and is lawful. Players convicted of a crime or subject to a disposition of a criminal proceeding (as defined in this Policy) are subject to discipline.

Case Study: NFL

- Reporting Clubs and players are obligated to promptly report any matter that comes to their attention (through, for example, victim or witness reports, law enforcement, or media reports) that may constitute a violation of this Policy. Clubs are expected to educate their employees on this obligation to report.
- "Workplace Setting" The workplace setting means any location or conveyance used in connection with NFL activities, including the club facility, training camp, stadium, locker room, location at which a club-sponsored event takes place, and while traveling on team or NFL-related business.

 You don't feel as guilty the more you do something bad.

Lying


- The Washington Post reported that most of us are pretty good at lying by age 5.
- University of Toronto study showed that at age 2, only 30% of us lie.
- At age 3, that jumps to 50%.
- By age 5 or 6, 90% lie.
- "When you tell lies, it costs your brain a heck of a lot more resources than when you tell the truth." – Kang Lee, University of Toronto



Why Discuss Ethics?

- This is a relationship business. An unethical behavior may be advantageous today but what impact will it have tomorrow?
- Would you want your insurance in the hands of unethical people?
- People talk and this is a small community.
- Being ethical forces you to think critically and potentially provide more value to your clients.
- Ethical dilemmas challenge all of us.



Another example of ESG ratings agencies failing to identify risk involved Volkswagen. In September 2015, the EPA issued a notice of violation of the Clean Air Act to auto manufacturer Volkswagen. This occurred after finding that the company intentionally programmed its turbocharged direct injection diesel engines to bypass emissions-testing software. This deceptive practice affected roughly 11 million vehicles worldwide produced from 2009 to 2015. The company subsequently agreed to pay more than \$25 billion in fines and penalties.

Volkswagen ESG Score vs. Peers 64









Data Ethics Canvas

 Data ethics are "A branch of ethics that evaluates data practices with the potential to adversely impact on people and society – in data collection, sharing and use."

- Data sources:
 - Name/describe your project's key data sources, whether you're collecting data yourself or accessing via third parties.
 - Is any personal data involved, or data that is otherwise sensitive?

- Limitations on data sources:
 - Are there limitations that could influence your project's outcomes? Consider:
 - bias in data collection, inclusion/exclusion, analysis, algorithms
 - gaps or omissions in data
 - provenance and data quality
 - other issues affecting decisions, such as team composition

- Sharing data with others:
 - Are you going to be sharing data with other organizations? If so, who?
 - Are you planning to publish any of the data? Under what conditions?

- Ethical and legislative context
 - What existing ethical codes apply to your sector or project? What legislation, policies, or other regulation shape how you use data? What requirements do they introduce?
 - Consider: the rule of law; human rights; data protection; IP and database rights; antidiscrimination laws; and data sharing, policies, regulation and ethics codes/frameworks specific to sectors (eg health, employment, taxation).

- Rights around data sources:
 - Where did you get the data from?
 - Is it produced by an organization or collected directly from individuals?
 - Was the data collected for this project or for another purpose?
 - Do you have permission to use this data, or another basis on which you're allowed to use it?
 - What ongoing rights will the data source have?

- Your reason for using data:
 - What is your primary purpose for collecting and using data in this project?
 - What are your main use cases?
 - What is your business model?
 - Are you making things better for society? How and for whom?
 - Are you replacing another product or service as a result of this project?

- Communicating your purpose:
 - Do people understand your purpose especially people who the data is about or who are impacted by its use?
 - How have you been communicating your purpose?
 Has this communication been clear?
 - How are you ensuring more vulnerable individuals or groups understand?

- Positive effects on people:
 - Which individuals, groups, demographics or organizations will be positively affected by this project? How?
 - How are you measuring and communicating positive impact? How could you increase it?

- Negative effects on people
 - Who could be negatively affected by this project?
 - Could the way that data is collected, used or shared cause harm or expose individuals to risk of being reidentified? Could it be used to target, profile or prejudice people, or unfairly restrict access (eg exclusive arrangements)?
 - How are limitations and risks communicated to people? Consider: people who the data is about, people impacted by its use and organizations using the data.

- Minimizing negative impact:
 - What steps can you take to minimize harm?
 - How could you reduce any limitations in your data sources?
 - How are you keeping personal and other sensitive information secure?
 - How are you measuring, reporting and acting on potential negative impacts of your project?
 - What benefits will these actions bring to your project?

- Engaging with people:
 - How can people engage with you about the project?
 - How can people correct information, appeal or request changes to the product/service? To what extent? Are appeal mechanisms reasonable and well understood?

- Openness and transparency:
 - How open can you be about this project? Could you publish your methodology, metadata, datasets, code or impact measurements?
 - Can you ask peers for feedback on the project?
 - · How will you communicate it internally?
 - Will you publish your actions and answers to this canvas openly?


- Ongoing implementation:
 - Are you routinely building in thoughts, ideas and considerations of people affected in your project? How?
 - What information or training might be needed to help people understand data issues?
 - Are systems, processes and resources available for responding to data issues that arise in the long term?

- Review and iterations:
 - How will ongoing data ethics issues be measured, monitored, discussed and actioned?
 - How often will your responses to this canvas be reviewed or updated? When?

Moral hazard

- A risk that someone takes because they know someone else will pay the consequences of that risk.
- The risk one party incurs when dependent on the moral behavior of others.
- A party has an incentive to take unusual risks to earn a profit.
- How behavior changes when people are insured against loss.
 - Ex. More likely to take risks if your car insurance is fully covered.

Moral hazard

- In finance, certain entities can view a government bailout as insurance against losses and thus take more risk.
- Paying a share of the cost to curb risk.
- In the financial crisis of 2008, this meant brokers selling subprime mortgage to people with poor credit, and then selling those mortgage to banks.
- Consequences for bad behavior in finance.
 - Dodd-Frank created to curb bailouts.





Empathy and compassion

Disheartening survey reveals nearly four in ten people experience days without talking to a single person.

LONDON — It's well documented that loneliness is on the rise in recent years. The coronavirus pandemic only adds to the problem, leaving many across the globe struggling mentally. Perhaps no better proof is a recent survey of 2,000 British adults, which finds that one in four people feel like they have absolutely no friends nowadays.

Moreover, 20% admit they have never felt more isolated than over the past three months. Forget the virus: 10% say that the isolation is hardest part of this entire pandemic.

So, why are so many people feeling like they've lost their friends? One in five are a bit salty toward their pals because no one has reached out since the pandemic first began. Meanwhile, 14% are afraid they've lost some friends forever due to not being able to se them in person lately.

The survey, commissioned by the UK online banking company Santander, also shows that some people aren't letting the coronavirus get in the way of their social life. A full 10% admit to knowingly breaking lockdown rules to go and see other people. Why take such a risk? Loneliness.
